Antonis C. Samaras

Prime Minister of the Hellenic Republic

Antonis C. Samaras is the Prime Minister of the Hellenic Republic and President of Nea Demokratia (ND). He was born in Athens on May 23, 1951. He is married to Georgia Kritikos; they have a daughter, Lena, 23, and a son, Kostas, 16. He holds degrees in Economics and Business Administration from Amherst College and Harvard University (MBA). From 1977 to 1993 he was a member of the Hellenic Parliament representing the

Prefecture of Messinia with Nea Demokratia and served as Minister of Finance and Minister for Foreign Affairs. In 1993 he was elected member of the Hellenic Parliament for the Prefecture of Messinia with the political party "Political Spring" (Politiki Anixi), which he founded and led till 2004. In 2004 he was elected member of the European Parliament with Nea Demokratia. He was member of the Budget Committee, the Committee for Economic and Monetary Affairs, the Committee for the Lisbon Treaty and the Committee of the EU-Russia Parliamentary Cooperation. In 2007 Mr. Samaras was elected member of the Hellenic Parliament for the Prefecture of Messinia with Nea Demokratia and was reelected in 2009. He was a member of the Standing Committee for Economic Affairs and the Committee for European Affairs of the Hellenic Parliament until January 2009, when he was appointed Minister of Culture. Under this capacity, he inaugurated the new Acropolis Museum in July 2009. In November 2009 he was elected the 7th President of Nea Demokratia by the party members. On June 20th, 2012, he was elected Prime Minister of the Hellenic Republic and formed a three party coalition government. He is fluent in English, French and Italian.



Makis Papageorgiou

Deputy Minister of Environment, Energy and Climate Change, Hellenic Republic

Born in 1956 in Athens, Greece, Makis Papageorgiou graduated from the Experimental School of the University of Athens (Peiramatiko) and obtained a Law Degree from the University of Thessaloniki. After a degree in Business Administration he obtained an MBA from Bentley University in Boston, Ma., USA. Prior to his appointment as Managing Director of Public Gas Corporation (DEPA) SA in December 2005, he worked for

more than ten years in several senior positions and as General Manager in various companies of the private sector in Greece and abroad mainly within the auto industry and the publishing and retail industry. From June 2004 till December 2005 he was the Managing Director of Suburban Railroad SA. He joined DEPA in December 2005 as Managing Director and from May 31, 2006 until December 16, 2009 as Chairman of the Board of Directors and CEO. From 2010 he worked as a consultant for Business Investments. He served as Deputy Section Head for Energy within the political party of New Democracy and on June 21 2012 he was appointed Deputy Minister of Environment, Energy and Climate Change. Makis Papageorgiou is a father of four children. He is fluent in English and during his leisure time he enjoys sports, cinema and theatre.

Kostas Andriosopoulos

Director, Research Centre for Energy Management at ESCP Europe

Dr. Kostas Andriosopoulos is the Executive Director of the Research Centre for Energy Management at ESCP Europe Business School where he holds the position of Assistant Professor in Finance and Energy Economics. He is also the Academic Director of the Master in Energy Management and Co-Director of the Executive Master in Energy Management. Kostas holds a PhD in Finance (Cass Business School, City University London),

His work has been published in numerous international finance-and energy-related Journals and has been presented in recognised conferences world-wide. He is the Associate Editor for the International Journal of Financial Engineering and Risk Management, he has edited special issues and has acted as reviewer for a number of recognised academic journals and has organised numerous international conferences. In addition to his academic profile he has an extensive professional experience in the business world. Kostas is an affiliate partner of 3H Partners since July 2013. Kostas has served as an advisor for a number of international clients from the energy, food, manufacturing, web & software, commodity trading and shipping industries. In addition to his consultancy role, Kostas co-founded in 2009 Symmetria Web Solutions, a web-based software company. He is also member of the board of Symmetria Ltd., a family owned commodities brokerage and trading firm. He has also worked for the British Bankers' Association reporting directly to the senior Director for Retail Banking and the CEO (2007). Kostas' mother tongue is Greek, he is fluent in English, and has a basic knowledge in Italian. He lives in London with his wife Chrysoula and his two children, Maria and Dimitris.



Alexandros Lagakos

Senior Gas Analyst, Shell Energy Europe and Chairman of the Greek Energy Forum

Alex is a Senior Gas Analyst in Shell Energy Europe in London and the Founding Chairman of the Greek Energy Forum. In his current role in Shell, he is responsible for the analysis of gas markets' fundamentals and is the focal point for European gas trading analytics for senior management within the Group. His duties include providing traders with personal price forecasts, trade recommendations and optimisation advice on trading

strategies. In the past, he has been a member of the Business Development Team of Shell Energy Europe, focused on the origination and negotiation of complex energy deals with major international companies. Before joining Shell, Alex worked for Gazprom as a Risk Analyst, involved in risk-due diligence on new market entries and innovative commercial products/structured deals on gas, electricity, carbon permits and biomass. He also possesses consulting experience, having worked in Mott MacDonald within the energy economics and finance team in the UK and having liaised with prestigious customers such as the World Bank and the Department of Energy and Climate Change (DECC). Alex has addressed a number of international conferences as a guest speaker and has participated in market consultation exercises as a company representative. He holds an MEng in Electrical Engineering from the Aristotle University of Thessaloniki and an MSc on Sustainable Energy Futures from Imperial College in London. He is an enthusiastic and active supporter of initiatives that aim at helping Greece accelerate its way towards a better future, as both his earlier political involvement as an elected municipal councilor at the age of 22 and his decision to start the Greek Energy Forum in London hopefully prove in practice.

Sergio Ascari

Gas Adviser, European University Institute

Born in 1958, graduated in Economics at the University of Pavia in 1982; M.Sc. (Econ.), University of York, 1985. Research assistant, research director and lecturer in Energy and Environmental Economics, in the Institute of Energy Economics (IEFE), Bocconi University, Milan (1982-94), and in the University of Pavia (1994-97). Worked extensively in the 1990's on the evaluation of external costs of energy generation and use,

also on behalf of the European Commission. Head of Gas Tariffs and economic regulation, the Environmental Unit and International Co-operation in the Italian Regulatory Authority for Electricity and Gas (1997-2006). Since 2002 he worked for the promotion and harmonisation of energy regulation and capacity building and training of energy regulators in Czech Republic, Lithuania, Turkey, Portugal, Ukraine, Egypt, and other countries. Gas Expert in the Regulatory Section of the Energy Community Secretariat in Vienna (2007-9), focusing on the Western Balkan gas market. Gas Advisor and Instructor of the Florence School of Regulation, in charge of gas training activities (since 2006). Took part in the development of the Gas Target Model for the European Union integrated gas market (2011). Senior Consultant, working mainly with REF-E, Milan, Italy, in the analysis and modelling of the European gas market and regulation (since 2009).



Miltos Aslanoglou

Vice Chairman B, Regulatory Authority for Energy

Miltos Aslanoglou is the Vice President of the Regulatory Authority for Energy as from Dec 2010. He served as the Head of the Energy Markets and Competition Department of the Greek Regulatory Authority for Energy (RAE) as from 2002. He has been actively involved in the preparation of the trading arrangements in Greece and the restructuring of the end user tariffs. Miltos Aslanoglou studied mechanical engineering,

economics and energy policy and before joining the Greek Energy Regulator, he was working for major electricity and natural gas traders in London.



Dinos Benroubi

Executive Director-General Manager PROTERGIA S.A.

Born in 1954 in Thessaloniki. B.Sc. and M.Sc. in Mechanical Engineering from Rice University (USA) and M.Sc in Management from Troy State University (USA). Has worked for 25 years in Titan Cement, where ultimately he held the title of Cement Division Director-Greece, and for 2 years in Viohalco as CEO of Elval S.A. He has been working for Mytilineos Group since January 2006. He has held the positions of CEO of Elvo S.A. (Defense

Industry), CEO of Delta Project (Renewable Energy), Zinc-Lead Metallurgy Director and Chairman of the Board of Endesa Hellas. Since July 2009, he holds the position of Managing Director of Korinthos Power and in parallel, the position of Executive Director - General Manager of Protergia S.A. Since October 2012 he holds the position of Vice President of the Hellenic Association of Independent Power Producers (HAIPP).



Thierry Bros

Senior Analyst, European Gas and LNG Markets, Société Générale

Thierry Bros was appointed Senior European Gas and LNG Analyst for Société Générale's Commodities team in 2010, having joined the group in 2007 as a Senior Financial Analyst to provide recommendations on listed pan-European gas stocks and in-depth research on gas issues. Thierry covered the gas chain from upstream to downstream with BG Group, Centrica, Enagas, Gas Natural, Gazprom, GDF SUEZ and Snam. From 2002 to

2007, Thierry was a Senior Oil & Gas expert at the French Ministère de l'Economie des Finances et de l'Industrie, where he represented France on oil markets and advised on emergency issues at the International Energy Agency (Paris), the European Commission and the Energy Charter (Brussels). His responsibilities included providing global oil and gas industry reviews to senior French officials and negotiating European directives. As a gas specialist, he reviewed the regulations governing the opening up and liberalisation of the French gas market and supervised the Contingency Gas Plan. Prior to that, Thierry was, for six years, Head of Internal Communications at IFPEN, an oil & gas research institute. Since 2011, Thierry has also regularly chaired sessions at the United Nations Gas Centre (Geneva). Dr. Bros is also a visiting faculty professor at several universities and a speaker at international conferences on gas-related subjects. He is the author of the book\(\mathbb{M}\)"After the US shale gas revolution" published, in 2012, by Editions Technip. In December 2012, Thierry was appointed as a member of the EU-Russia Gas Advisory Council which provides recommendations on long-term gas cooperation to the Russian Federation Minister of Energy and the European Commissioner for Energy.



Pantelis Capros

Professor, National Technical University of Athens

Prof. Pantelis Capros heads the E3MLab of ICCS. He is a Professor of Energy Economics and Operation Research at the Department of Electrical and Computer Engineering of National Technical University of Athens. He has built and used a variety of large-scale mathematical models and has more than 20 years professional experience of consultancy in the domain of energy and economic policy. For the MEDPRO

project, E3MLAB will use and apply the GEM-E3 general equilibrium model. In particular, the model version developed already for the integrated FP6 research project CIRCE studying impacts of climate change on the Mediterranean economic and ecological system.

Chairman, Hellenic Association of Photovoltaic Energy Producers

Born in Athens he graduated Chemical Engineer in National Technical University of Athens (NTUA) in 1992. At post-graduate level he has been awarded the degree of Master of Business Administration (MBA) from Portsmouth University of U.K. Furthermore he has attended dozens of seminars and courses in technical, financial and managerial field while many of them related to photovoltaic technology and PV plant design. He

started his professional career in the family business for decades involved in exports of garments to European markets. In this company he developed a new department trading OTC para-pharmaceuticals, diagnostic tests and health products both in Greece and Cyprus. He worked for five years as an executive in Marketing and Sales in a multinational and later a Greek industrial company producing and trading fast moving consumer goods (FMCG) and food products. Back in business he was involved in the rapidly expanding sector of organized food retail. In 2006 he entered the field of power generation through photovoltaic (PV) technology. He pioneered in Greece developing centralized PV plants. His company's first centralized PV plant was one of the first of its kind in the country and was connected to the grid in April 2008. 
